Re: Right-to-Know Law Request received September 12, 2017;

Request for copies of records identifying the federal dollars paid to each Pennsylvania county for child support enforcement.

Dear Ms. Macfarlane:

On September 12, 2017, the Office of the Budget's Agency Open Records Office received your written request made pursuant to the Commonwealth's Right-to-Know Law (RTKL), 65 P.S. §§ 67.101 *et seq*. Your request stated the following in pertinent part:

I am trying to learn the total dollars paid by the Federal Government to the state of Pennsylvania for child support enforcement reimbursements (Title IV-D money). If possible, I am seeking a break-down of the moneys paid to each county. On the US HHS website (HERE), for example, they show \$3.89 billion for "Child Support Enforcement and Family Support" for 2015.

The Office of the Budget has completed its review of your request and its records and provides you with this final response.

The table below provides the federal child support enforcement dollars provided to each Pennsylvania county payee for state fiscal year 2015-16, as well as the sum total of those amounts.
